Upon acceptance of the application and contract by Energy Bar Association (EBA), the undersigned agrees to be bound by the Terms and Conditions as set forth within the application. Acceptance of the application is at the sole discretion of EBA. In order to be assigned virtual Solution Center space, all applications/contracts must be signed, and payment provided.

Terms and Conditions: The exhibitor is responsible for creating and providing content to EBA. If the exhibitor fails to respond or fails to deliver content, EBA shall be under no obligation to provide a refund. Partners will only promote products and services regularly sold by them. No products and/or services will be directly sold from within the conference platform. No virtual booths may be shared without prior written permission of EBA. Failure to comply is deemed cause for cancellation of the space.

Full payment is due with the completed contract. Cancellation is required in writing. There are NO REFUNDS on cancellation of a Solution Center Package.

All exhibits and related marketing materials shall serve the interests of EBA members.

EBA reserves the right to determine the eligibility of any company, product, or service for inclusion in the Solution Center. The EBA reserves the right to remove or prohibit any material that in its opinion are not in keeping with the character and purpose of the virtual conference or that serves the interests of its members and guests.

Cancellation or Change of Program Dates or Venue

In the event that the Platform or system through which the Event or Solution Center is to be conducted should fail or become disrupted or unworkable by reason of any cause or causes not reasonably within the control of EBA or its agents, the Event and/or Exhibit Hall may be canceled or changed to another option, at the sole discretion of EBA. EBA shall not be responsible for delays, damage, loss, increased costs or other unfavorable conditions arising by virtue of cause or causes not reasonably within the control of EBA.

Photography, Videotaping and Recording
