

CFEBA Annual Fundraising Gala "Empowering Education in Haiti"


Gala Attire: Business or Festive *Must be pre-registered to attend this event. No tickets will be sold onsite.



Commissioner Bernard L. McNamee was nominated to the Federal Energy Regulatory Commission by President Donald J. Trump in October 2018 and confirmed by the U.S. Senate on December 6, 2018. Before joining the Commission, Commissioner McNamee served in a number of legal and policy

positions at the state and federal level throughout his career. 

Commissioner Cheryl A. LaFleur was first nominated by President Barack Obama to the Federal Energy Regulatory Commission in 2010 and was confirmed for a second term by the Senate in 2014. She served as Acting Chairman of the Commission from November 2013 to July 2014 and January to

August 2017 and as Chairman from July 2014 until April 2015.

Since she joined the Commission, her priorities have included reliability and grid security, supporting the development and evolution of robust competitive markets, promoting regional transmission planning, and supporting a clean and diverse power supply. She is a member of the NARUC Committees on Electricity and Critical Infrastructure and was co-chair of the FERC/NARUC Forum on Reliability and the Environment. She is a frequent speaker on energy issues.

Hearings are impractical anytime the amount in controversy is less than the cost of litigation. This panel discusses an innovative hearing format that would address this problem by suggesting an example of a "minitrial," mentioned in Rule 604; and amending Rule 218 to provide similar structure for complaint cases with \$1M or less at issue.

Natural gas pipelines collaborate with the U.S. Department of Homeland Security's Transportation Security Administration ("TSA") and the U.S. Department of Transportation ("DOT") on cybersecurity risks and potential cyberattacks pursuant to DOT's 2002 Pipeline Security Information Circular and TSA's 2018 revised Pipeline Security Guidelines, adopting the National Institute of Standards and Technology ("NIST") Framework for Improving Critical Infrastructure Cybersecurity. Roughly half of all electric transmission capital expenditures in CAISO, MISO, and PJM are for repair or replacement of existing facilities. Today, this work receives varying levels of third-party review through state and RTO/ISO processes. 


