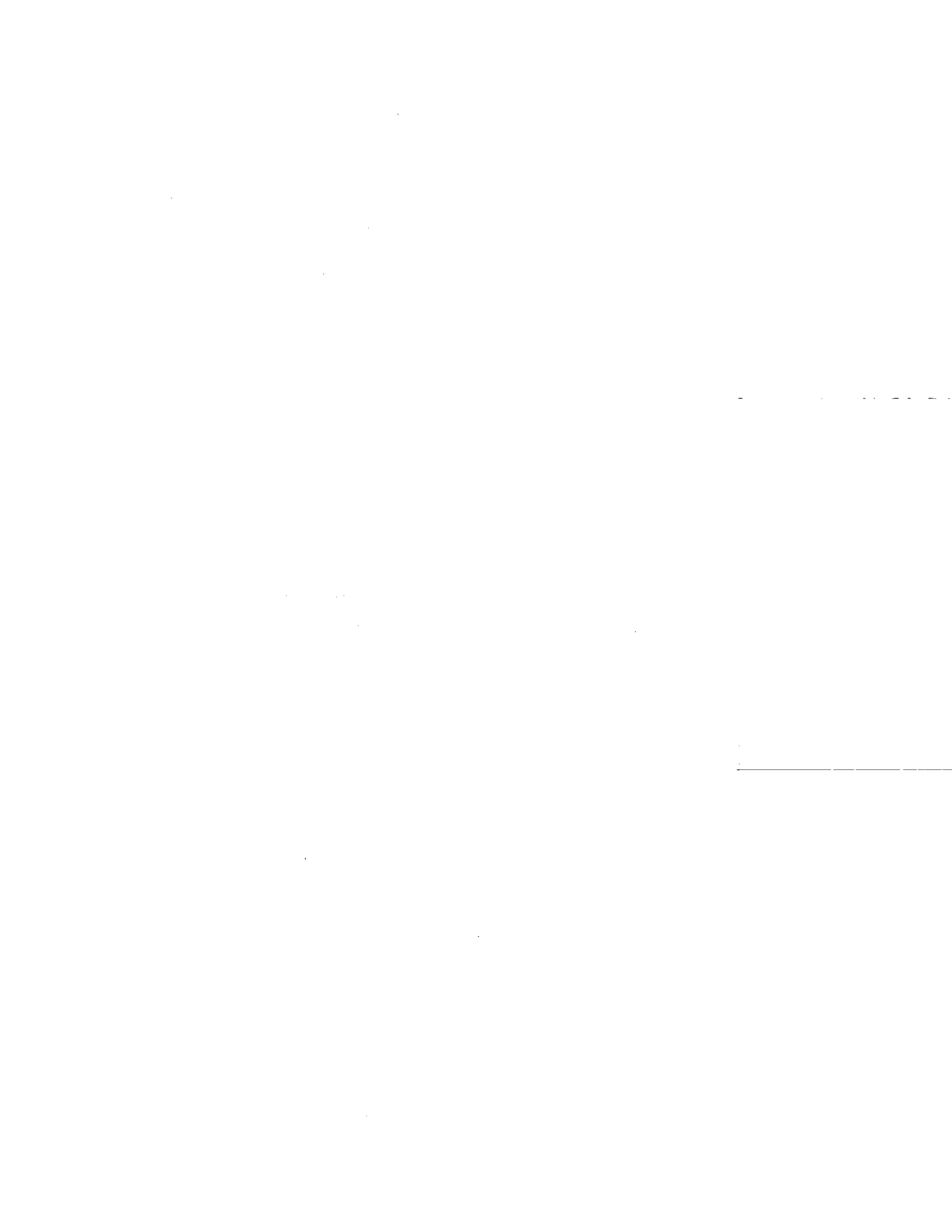

IN MEMORIAM

Richard A. Solomon, who brilliantly served the public in a number of capacities, died on January 23, 2005.

Dick, born in New York in 1917, graduated from Harvard in 1939, and received his law degree from Yale in 1943. He became a JAG Officer serving in the China-Burma-India theater during World War II and was a prosecutor of Japanese war criminals after the war. When he returned to civilian life, Dick joined the Federal Communications Commission where he held a variety of positions from 1947 until 1959. Dick's next stop was as the Deputy Chief, and later Chief, of the Appellate Section of the Anti-Trust Division at the Justice Department.

Dick's energy law career began in 1962 when he was appointed General Counsel of the Federal Power Commission. During his seven-year tenure as General Counsel, Dick used his considerable appellate skills to defend the Federal Power Commission's major policy endeavors: of improving the reliability of the electricity grid and developing area and national rates for sales of natural gas. While at the Commission, Dick was honored as a recipient of the Tom C. Clark Award, the highest award for a federal government attorney, from the Federal Bar Association.

In 1969, Dick joined the law firm of Wilner & Scheiner where he turned to representing state and local interests, primarily the Public Service Commission of the State of New York and other consumer interests in a wide range of cases before the Federal Energy Regulatory Commission. Dick retired in 1994 from the law firm of Morrison & Hecker. Throughout his fifty-year legal career, Dick was known for his skillful appellate advocacy, having argued a dozen cases before the Supreme Court and innumerable times before the Circuit Courts. Dick served as President of the Energy Bar Association in 1985-86.

Dick freely shared his incredible legal skills with many lawyers whom he mentored throughout his career. While he was a fierce advocate, he never took himself too seriously and had a wonderful sense of humor. He coupled those qualities in his self-created persona as an "absent minded professor." Who can forget hearing his voice from the back of a hearing room asking, "What case is this?" and then watching him ask the toughest cross questions going to the heart of the case?

IN MEMORIAM

Radford Lawrence Schantz, age seventy-nine, who retired in 1989 as President of Foster Associates, an economic consulting firm specializing in energy and regulated utilities, died January 20, 2005, at his home in Bethesda, Maryland. He had lung cancer. Mr. Schantz was a founding member of Foster Associates in the mid-1950s. After his retirement, he remained active in community affairs and continued to play the clarinet.

He was born in Gainesville, Georgia, and spent his high school years in Lowville, New York. Mr. Schantz served in the Navy in the Pacific during World War II and participated in the Battle of Leyte Gulf.

He was a 1949 electrical engineering graduate of Syracuse University, and in 1952 he received a master's degree in business administration from New York University. Early in his career, Mr. Schantz did electrical engineering work for Consolidated Edison Co. in New York and taught economics at NYU and Harvard University.

He was a member of River Road Unitarian Church in Bethesda as well as the Bethesda-Chevy Chase YMCA, where he also did volunteer work and developed the seniors' tennis league. Survivors include his wife of thirty-eight years, Erika Bading Schantz of Bethesda; two children from his first marriage, Radford Schantz Jr. of Arlington, Virginia, and Douglas N. Schantz of Houston, Texas; two children from his second marriage, Susanne E. Schantz of London, England, and Thomas B. Schantz of Alexandria, Virginia; two brothers; and six grandchildren.

Mr. Schantz led Foster Associates during a period of profound changes in the energy industry and government regulation. He testified extensively concerning energy and regulatory policy. His wisdom and industry made him a giant in the field. He was a friend and mentor to many of us.
