Steve graduated from Arizona State University in 1976 with a Bachelor of Science in Civil Engineering. He joined the Arizona Department of Health Services, Environmental Health Services Division (later to be the Arizona Department of Environmental Quality) in 1978 after completing two years of graduate studies specializing in Environmental Engineering. In 1983, Steve started working for the Arizona Corporation Commission (Arizona's public utility commission). At the Commission, Steve held several positions beginning as a Water/Wastewater Engineer, then Engineering Supervisor, Chief Engineer and Utilities Division Assistant Director. Before retiring from the Commission in August of 2015, Steve spent his last five years at the Commission as the Director of the Utilities Division.
