Prior to being named General Counsel, Matt Christiansen served as a Legal Advisor to Chairman Glick. He joined then-Commissioner Glick's office in 2017 from the Commission's Office of the General Counsel. Before joining Commission staff, he served as a law clerk to the Hon. Stephen F. Williams on the U.S. Court of Appeals for the District of Columbia Circuit and the Hon. Jesse M. Furman on the U.S. District Court for the Southern District of New York. He was also an Energy Law and Policy Fellow at NYU Law School's Guarini Center on Environmental, Energy and Land Use Law. His academic work has appeared in or is forthcoming in the Harvard Law Review, the Texas Law Review and the Energy Law Journal.

Judge Sophia Park, California PUC Senior Administrative Law Judge

Judge Sophia Park joined the California Public Utilities Commission in 2007. She started as an attorney handling applications for rehearing of Commission decisions and defending the Commission's decisions before the state appellate courts. She has been an ALJ with the Commission since 2015. Her cases primarily focus on energy matters, although she handles water and other matters as well. Judge Park also oversees revisions to the Commission's Rules of Practice and Procedure and trains new judges and staff regarding Commission procedures. Judge Park is a graduate of U.C. Berkeley and U.C. Berkeley School of Law.

Judge Sarah Harpring, ACC Assistant Chief Administrative Law Judge

Judge Sarah Harpring has been an ALJ with the Arizona Corporation Commission since August 2007 and has served as the Assistant Chief Administrative Law Judge ("ACALJ") since September 2017. As ACALJ, Judge Harpring is the direct supervisor for 9 ALJs. Judge Harpring moved to Arizona in 1998, after serving on active duty for several years as a U.S. Army JAG officer in Darmstadt, Germany. Before working for the Commission, Judge Harpring worked for the Arizona Department of Agriculture briefly and then for the Arizona Department of Health Services for 8 years, where she served as a Senior Rules Analyst and for her last 18 months also as Assistant Administrative Counsel. Judge Harpring earned a B.A. from Miami University in Ohio and a J.D. from the University of Cincinnati College of Law. Judge Harpring is married and has two sons (now adults) and three dogs. She has volunteered as a big sister for Big Brothers/Big Sisters and as an appointed member of a Maricopa County Foster Care Review Board.

Judge Michael Howard, Washington UTC Director and Administrative Law Judge

Judge Howard serves as Director of the Administrative Law Division and Acting Policy Director at the Washington Utilities and Transportation Commission. Since joining in February 2020, Judge Howard has presided with the Commissioners over general rate cases, litigated Clean Energy Implementation Plans, power cost only rate cases, and other proceedings. He has presided alone over a variety of other proceedings, and he assisted the Commissioners with the creation of Washington's Participatory Funding program.

Wildfire Preparedness for Utilities

Before joining BB&W, Justin was a law clerk at the Sacramento Municipal Utility District. Justin graduated from the University of California, Santa Barbara in 2003. Prior to joining Energy Safety, Melissa served as an administrative law judge with the California Public Utilities Commission. She presided over some of California's highest profile energy cases involving many stakeholder groups and multibillion-dollar outcomes. In this role, she authored seminal decisions on Public Safety Power Shutoffs and the California Climate Credit.
