### The Jason F. Leif Chapter Service Award

In February 2018, the Energy Bar Association created the Jason F. Leif Chapter Service Award in memory of Jason F. Leif, a past EBA President, a past President of the Houston Chapter of the EBA, and a motivating force in the revitalization of the Houston Chapter. This award honors and recognizes exemplary long-term service, or one or more particularly significant examples of service, by an EBA member to one or more of the EBA Chapters. Exemplary service to the community in connection with EBA Chapter activities may also be considered. The award is granted as deemed warranted by the EBA Board and may, or may not, be granted annually. In May 2018, Jason was presented the first award, posthumously.
