Among members of the energy bar, Paul E. Nordstrom was held in very high esteem. Nordstrom, a former EBA President and the guiding force in creating the Charitable Foundation of the Energy Bar Association (CFEBA), was one of the country's leading energy attorneys representing a variety of clients in the electric power industry on regulatory and power supply matters.

In recognition of his influence, service, and impact on the Association, EBA established the Paul E. Nordstrom Service Award following his passing in 2008. Today, we are calling upon EBA members to recommend candidates for the award named in his honor.
